### **ALUMNI SPOTLIGHT**

Communication Studies Alum Steve Judice Excels in Courtroom and on Stage



Texas Red Dirt music gets its name from the color of the soil in Oklahoma and features artists like Cross Canadian Ragweed and Casey Donahew Band. With the recent growth of the popularity of this music, who would have known that one of our alums is not only a lawyer, but also a successful Texas Red Dirt/Americana musician? Meet Steve Judice (M.A. 1980). Steve is a songwriter from Baton Rouge, Louisiana, who has released three solo albums and has opened shows for artists like Guy Clark, Billy Joe Shaver, and Ray Wylie Hubbard. Steve enjoys playing at music festivals throughout Texas, Louisiana, and Mississippi.



Steve attended graduate school in the late 70's at North Texas State University. Steve chose to get his Masters in speech communication because he participated on the debate team in high school and college. He was also a speech education major during his undergraduate program at the University of Southwestern Louisiana (now called University of Louisiana at Lafayette). Steve didn't know what he wanted to do with his life, but knew that he wanted to stay in academia. Steve emphasized, "there is a buffet of options in front of you when you're young, and it is important to explore different avenues and love what you do."

Steve moved to Denton with his wife Kathy to complete their graduate degrees and while here they both assisted the UNT Debate Team. Steve and Kathy shared a desk in the graduate assistant office and were together almost 24 hours a day. All of that time together could either wreck a marriage or make it stronger, and their marriage has been strong for the past 37 years. Steve and his wife have four daughters, including a teacher and mother of two, a manager at an orthodontics office, a professional dog trainer, and a singer on a cruise ship. Steve said his daughter who works on the cruise ship "has the amazing opportunity to see the world on somebody else's dime," while also carrying on the family's musical legacy.

Steve spoke about Denton life while he was in graduate school and recalled that it was a relatively small town. "Denton would just go to sleep on the weekends," instead of having the bustling nightlife that it has now. Also, "Fry Street only had private clubs with any place selling beer or hard liquor needing memberships." He did recall a drive-in beer barn on Fry Street, which we are sure many students wish was still there. Being the outstanding student that he was, Steve didn't spend too much of his time on Fry Street, and instead spent much of his time with his studies and music.

After graduating from UNT, Steve moved on to teach debate at the University of Louisiana at Lafayette. After teaching for a short time, he realized that teaching wasn't for him. His wife Kathy suggested law school and it was there that he discovered a passion for law. He found that his communication degree helped, especially in trial work, to connect with the jury and establish credibility. Steve stated that "understanding communication and communication behaviors is vital to success in a trial."

However, Steve is not just a lawyer. He emphasizes the importance of "finding joy in the other things that you're doing," which inspired him to start a music career. Steve found his passion for music when his aunt gave him the 1961 vinyl of Jim Reeves album, "Tall Tales and Short Tempers," when he was 10 years old. Steve said "I practically wore that record out. It may have been around that time that the seeds of songwriting were sown." Steve started playing guitar at 16; his brother-in-law was in the Navy and would leave his guitar with Steve when he would ship out. Steve said that learning to play "G, C, and D chords lets you play every country song," such as Johnny Cash's "Ring of Fire."

Playing music, as he suggests is, "a wonderful release." Steve said he could sit for hours at his guitar and piano and forget about work and stresses. He started performing after he went to graduate school and began writing his own songs around 2005-06. Steve said that in order to write music, "you need to be willing to receive inspiration from wherever it comes," but it doesn't hurt that his wife talks like a songwriter to be his inspiration. He even expresses this in "Kathy's Song" by saying "They say we're shaped and defined by the things we love."



Because of Steve's success in music, he was able to play at his "bucket list" venues, including the legendary Gruene Hall and Riley's Tavern, which is the oldest bar in continuous operation in Texas. Steve has also played Geezer Fest at Oma Greens for six years in a row. Steve has played alongside Rodney Parker and Fifty Peso Reward, a band from our very own town of Denton.

Steve comments that Communication Studies has influenced his work as both a lawyer and musician, however it also influences his daily life. As Steve said, there are so many options that you have when you're young, and his degree has helped him to be successful in his career and find joy in life. 






The installation art piece, "Purple Rain\Rein\Reign" from the Intertextuality & Performance Class.

#### Debate-A-Palooza



UNT Debate once again sponsored Debate-A-Palooza, this time on November 21. This public event features a series of public debates held by UNT Students all on the same day. This year students debated the Denton confederate monument, legalization of marijuana in Texas, legalizing prostitution, body cameras for police, carbon emissions, raising the minimum wage, physician assisted suicide, campus carry, and defunding Planned Parenthood. Also this year, Debate-A-Palooza students participated in the National Aeronautics and Space Administration's astrobiology debates topic, which was, "Resolved: An overriding ethical obligation to protect and preserve extraterrestrial microbial life and ecosystems should be incorporated into international law." #### Maymester in Nicaragua with Comm Studies

Dr. Brian Richardson will be teaching a Study Abroad course in Nicaragua during Maymester 2016. The course, which will be co-taught by Emergency Administration professor Dr. Laura Seibeneck, addresses International Disaster Communication. After meeting in Denton for lectures and to discuss logistics, the students and instructors will spend one busy week in They will visit three of Nicaragua. Nicaragua's most prominent cities, including Managua, Granada, and Leon, learning from officials and



professors how the country prepares for, responds to, and recovers from disaster situations. Students will also learn about Nicaraguan history and culture. The course will be facilitated by Explore 505, a study abroad provider in Nicaragua, led by UNT alum Anthony Spencer. This is the second such course offered by Drs. Richardson and Siebeneck; the first group traveled to Peru.
